Arrangements for commercial exhibit/sponsor or advertisements cannot influence planning or interfere with the presentation; nor can they be a condition of the provision of commercial support for CPD activities.

Advertisements and promotional materials cannot be displayed or distributed in the educational space (lecture theatre, etc.) immediately before, during, or after a CPD activity. The exhibitor/sponsor will not distribute medication or device samples at the CPD activity.

The exhibitor/sponsor will not provide incentives (regardless of the nature or value of the gift) at the CPD activity unless written approval is received from the CPD provider/physician organization. This includes, but is not limited to items such as textbooks, electronic media, meals, gift certificates, tickets, devices, products or services, travel, hotel accommodations, entertainment or payments for attending a meeting.)
